
## PRESIDENT'S MESSAGE

## **COVID-19 Campus**

In mid-March, rumblings about travel restrictions and self-isolation turned into cancellation of all face-to-face classes for the rest of the term. A week of class meetings (March 16-20) was cancelled, with the objective of giving instructors time to "move classes to an alternative format". If you recall the last few weeks of a semester, with faculty wrapping up lecture content and students finishing labs, reports (and bell-ringer exams?), and giving presentations and submitting essays and research projects, you might wonder how all this could be re-packaged for campus courses ... in a week! People performed miracles, with much help from the technical staff in CourseLink and Computing Services. Instructors had to think about how much more course information was really essential, and try to keep the delivery simple, while they and their students navigated new technology. How were instructors and students to respond to the many unknowns?

It helped that courses in which 60% of the assessments for the semester had been completed could have marks assigned on the basis of that work. Take-home exams or assignments or on-line exams could also be used to complete requirements. A calming influence was the fact that students had the option to receive either a numerical grade or a "Pass", or to drop the course, and all that at the end of the semester. You wonder how an on-line exam can be invigilated. Long practice from the university's Distance Education experience and the Respondus software enabled secure and timelimited on-line exams

The COVID-19 information site on the University website shows the day-by-day changes from mid-March to the present day, with UoG President Franco Vaccarino's frequent updates. Staff began to work from home where possible. Library and Hospitality Services scaled back operations and then closed by March 20th, and more than 4000 students moved out of residence. Arrangements were made to consolidate housing for international students and others who could not return home. June Convocation ceremonies were postponed, as was Alumni Weekend. Conferences and other events on campus were cancelled, and on April 1st, it was announced that face-to-face course delivery would be cancelled for the Summer 2020 semester – no fooling! Courses and exams would be offered, following a modified presentation format.

Research activities on campus were also winding down, including work on many graduate student projects. Some thesis examinations and other graduate exams were conducted as the semester ended – but by on-line video links with reduced numbers of spectators. Access to laboratories and other facilities became increasingly restricted, to the point where only work to maintain critical living materials (animals, plants, microbes and cell lines!) was continuing. Serious questions arose over normal funding for graduate students and their research

There are still many, many questions about how the next months and semesters will unfold on the UoG campus – and indeed, at all universities. Many people have been working hard to find the way forward, and we recognize at least some of the things they are dealing with and wish them, and the university's students, all the very best. Be well!

# Pension Update and Message from the University Administration

The new University Pension Plan (UPP), an initial partnership of UoG with the University of Toronto and Queen's, will preserve our precious defined-benefit pension program. The UPP was formally established January 1, 2020 with the appointment of a fourteen-member Board of Trustees. Ms. Gale Rubinstein was appointed inaugural Chair of the Board by the UPP Joint Sponsors.

Current employees of all three universities will begin earning credited service under the UPP from July 1, 2021. Current retiree pensions are unaffected by the UPP conversion, although payments may come from a different disbursing agent.

Our current UoG pension plans, at their fiscal year ending September 20, 2019, had combined assets of \$1.61 billion. The investment return for the year was 4.5%. Disbursements to current retirees totaled \$78.8 million. Retirees (and survivors) make up almost 40% of total membership in Guelph's three plans.

During the past six months, the Board of Governors' Pension Committee completed an actuarial valuation (i.e. the "liability view") of the two major plans (professional and retirement) as of October 1, 2019. The valuation indicated a going-concern deficit for the combined plans of \$97.8 million and a funded ratio of approximately 94%. The solvency calculation (wind-up less indexation) indicated a combined deficit of \$416 million, and a funded ratio of 79%. This latter calculation will likely not be required when the UoG plans move to the new UPP. Additional actuarial valuations will be completed in the coming year, effective October 1, 2020, and again at the "conversion date" tentatively June 30, 2021. The University will be responsible for addressing any funding deficit as part of the UPP transition.

Moving toward the new jointly sponsored UPP pension plan has been an arduous process. In the turbulent environment we are experiencing currently, I would not be surprised if there were a few new challenges to address before the migration is completed.

#### Pension Indexation Note

The annual indexation calculation is based on the May-April year for all three UoG pension plans. This year's average CPI increase for the 12 month period ended April 30, 2020, compared to the prior year is 1.81% (calculation confirmed with Human Resources). Therefore, there will be no pension increase for this year.

We haven't been in touch for a while and thought a short note should be sent to confirm that, regardless of the COVID-19 impact on financial markets and the economy, the University of Guelph pension plans are financially strong enough to weather the present uncertainty. Members should not be concerned about their pension and retiree benefits.

The University of Guelph continues to partner with the University of Toronto and Queen's University to merge pension plans effective July, 2021. The merger will financially strengthen the pension of the three universities. Again, as has been stated previously, it's important to emphasize that the merger will not have any impact on existing pensions.
