#### PRESIDENT'S MESSAGE

Had T.S. Eliot experienced April in Guelph, he might have thought twice before calling April "the cruelest month." Drab slush has melted, colour is returning to the trees and finches are battling for territory at my bird feeder. This is a particularly beautiful time of year in Guelph, following the warmest winter many of us can recall. As I made my way to our Spring Forum this past week, I was refreshed by the power of renewed life in the Arboretum.

Before I joined the UGRA executive, I wasn't really tuned in to our annual events, the forums in spring and fall and the Annual General Meeting in June (that also features a keynote speaker). I have come to enjoy and anticipate these meetings, because they offer a chance to reconnect with past colleagues, and more importantly to me, to meet and befriend people who worked in areas of the university that I never traversed.

Many of us spent our working lives siloed by colleges, departments, and jobs. For much of my career, I met only a few people outside of my own college, and it was not until I became involved with UGFA that I got to know colleagues from other sectors. And even then, most of the people I met were faculty. The only staff members I knew were those that I worked with in my department. UGRA has changed that for me, because we are in one fundamental way a rare bird among university retiree associations in Canada. Every retiree who draws a pension from the University of Guelph is automatically a member of UGRA, regardless of job sector or bargaining unit. The UGRA executive offers a snapshot of the university's multiplicity, with former faculty and staff from (in no particular order) Financial Services, the Animal Health Lab, Plant Agriculture, Pathobiology, Student Housing Services, Molecular and Cellular Biology, Theatre Studies, Family Relations and Applied Human Nutrition, Hospitality, Food and Tourism Management, Integrative Biology, and Computing and Communication Services. Although we conduct our meetings online, we do meet up occasionally, and on one such occasion, as I was on campus with a fellow executive member, we reflected on the fact that we had worked in the same university for over 30 years without ever meeting; I had never stepped



in his building nor he in mine. My involvement with UGRA has revealed to me how vastly complex and fascinating the university is. In the ongoing and often highly stressed periods of cutbacks (now more severe than ever, we hear), it was sometimes hard to sustain pride in our institution, but for me, UGRA has restored that sense of attachment.

This is my final message as president, and I want to take a moment to thank my fellow executive members for their support and help. In a few weeks, I will end my term at the AGM and Clarence Swanton will pick up the gavel (really a cowbell). Clarence has been an outstanding VP of the association, and led the initiative to review and reform our constitution, with amendments to be circulated and put to a vote at our AGM. He will be an excellent president.

As you can read in this newsletter, our Spring Forum featured speakers on the subjects of endof-life estate planning and the housing crisis in Guelph. Our AGM speaker, Ryan Fraser (<a href="https://www.quietlegacy.com/">https://www.quietlegacy.com/</a>) will offer more on the subject of end-of-life planning. I want to express my gratitude to our friends and associates in Alumni Affairs and Development, in particular Jayne Whitfield (Senior Manager, Legacy Giving), and Jana Miller (Associate Director, Annual Giving), for their work on arranging the details of the presentation. And, I want to express my profound appreciation for their enthusiastic and generous help throughout the year.

#### **UPDATE:** Benefit Premium Changes

Many factors have combined to result in the large increase to New Plan dental premiums. Last year, the full premium increase recommended by Sun Life was not passed along to retirees and was paid from a now-depleted plan surplus. This delayed increase from the previous year, the inflation reflected in the newest Ontario Dental Fee Guide, and continued high utilization of the dental benefits by our New Plan retirees were all contributing factors to this premium increase.

#### **Spring Forum Speaker Report:**

# Estate Planning Tips and Traps

The spring forum presentation "Estate Planning Tips and Traps" featured an excellent talk by Debbie Stanley, the founder and President of ETP Canada, a Guelph firm that specializes in Estate Administration. As she noted, estate planning is not everyone's favourite topic, but she stressed that it's a very important one. Everyone over 18 needs a will to ensure that their assets are properly managed and distributed after their death. Wills can also cover other important issues such as appointment of an executor, guardianship of minor children, and funeral arrangements. They're difficult discussions, but once estate plans are in place, it's important that everyone involved has a good understanding of your wishes. It is also important to do a regular (5-year) review of your will or when you've had major changes in your life.

As part of estate planning, Debbie suggested that we treat the appointment of an executor like a job interview. For example, your eldest child might not have the needed skill set or the necessary time to deal with an estate and other family, friends, or professionals may be able to do a better job. Remember settling even a simple estate can take many hours and often the process can go on for years.

In addition to a will, power of attorney documents for making both financial and health care decisions on your behalf when (not if) you become incapacitated are also essential. Beyond the simple checking of boxes for various medical procedures, it's important that the person with your power of attorney is clear about your

values. For example, if you're keen on running with your dog through the woods, then spending your last days immobilized and alone in a dark room in a big city would not be ideal.



Debbie also reminded us that beneficiary designations are a great tool to pass on proceeds from RRSPs, TFSAs, RRIFs, and insurance policies. These funds can be released immediately, and do not need to await probate - a process that can take weeks (or even months in places like Toronto). Again, visit your account statements regularly to ensure that the money will go to the right person.

Debbie also discussed probate, a legal process of validating a person's last will and testament as well as assessing probate tax. She suggested strategies to avoid probate tax are often complex, and not worthwhile in the end. Debbie also noted that if there is no will, validating the executor and beneficiaries happens under the Succession Law Reform Act, R.S.O 1990 c. S.2 - a process that is often less than optimal for all concerned. To help with the probate process, Debbie advised that it helps to prepare a document that includes essential information such as a list tangible assets like cars, and houses, and valuable family heirlooms as well as account numbers and passwords. In addition to some of the more obvious things like bank and utility accounts, someone may have to close your social media accounts or try to retrieve precious pictures so

that information is also needed. Downloading your pictures and having a readily accessible file with key information on a USB key can be helpful. Once you've done that organization, it is crucial that you put your will and supporting information in a place that can be accessed by your lawyer or trusted friend/relative. For example, do not place your will in a bank safety deposit box since the bank may not open it without clear instructions or legal authority. This will delay the process of executing the will. As with all stages of the process, communicate, communicate, communicate.

In conclusion, the presentation on Estate Planning Tips and Traps was a real eye opener (or useful reminder) for all of us who will be dealing with estates one way or another. Remember, there are options for engaging professional services (trust companies, banks, or certified professionals like Debbie) instead of burdening family or friends with an onerous and sometimes lengthy responsibility. All executors are entitled to compensation (4 to 5% of estate value) so paying for a professional with expertise in estate administration might be worthwhile.
