1. CALL TO ORDER

5. PRESIDENT'S REMARKS

On behalf of Kent Percival, Robin Davidson-Arnott briefly outlined some of the UGRA highlights of the past year. These included the Fall Forum on brain health and the Spring Forum on surviving climate change that were both well-attended. The President's reception in September 2016 highlighted the renovations to MacDonald Hall. Another social highlight was a dinner cruise on the Grand River in August 2016, organized by Peter Kevan. Peter is also planning a UGRA trip to Churchill MB for the summer of 2017. The UGRA executive also engaged in a strategic planning session. Other UGRA initiatives have included enhanced communication with the University of Guelph and a guide to retirement planning (on the UGRA website). Kent also passed along his thanks to the UGRA executive and to the three retiring UGRA executive members (Thom Hermann, Robin Davidson-Arnott, and Jamie Snell).

6. REPORTS

a. Funding of the UGRA Scholarship

Frances Sharom presented a report on the status of the UGRA Scholarship

- * In Fall 2016, the UGRA scholarship fund was at ~\$19,600, and the decision was made to launch a campaign to raise this to >\$30,000, so it could be endowed to provide a \$1,000 amount in perpetuity
- * As an added inducement, I agreed to match funds up to \$5,000, and the response from retirees was wonderful; we raised over \$17,000 and counting
- * The scholarship is now endowed, donations are still coming in, and the current value of the scholarship fund is over \$37,000
- * UGRA will continue to accept donations until the fund reaches \$45,000, which will provide the full value of the \$1,500 scholarship
- b. Pension Update

Doug Badger presented an update on the pension status as follows:

- * August/2016 Actuarial Valuation:
- o Market Value of combined plans: \$1,333 million
- o Active members: 3,250
- o Retired & survivors: 2,265
- o 'Going concern' deficit: \$109 million
- o 'Solvency' deficit: \$615 million
- o Estimated annual minimum University contributions: ~\$60 million
- * JSPP Progress:
- o Core group of 3 institutions (UofT, Queens, UofG)
- * 'Solvency' deficit relief
- o New provincial funding framework announced May 19/17.
- * 2017 Inflation Adjustment: "nil" (1.52% annual CPI @ April/17)
- c. Treasurer's Report and Nomination of the Auditor

Cathy Ralston reported total revenues of \$9921 and expenditures of \$9,254 for 2016/17, which resulted in a surplus of \$697. Total assets are ~\$12,000.

Cathy Ralston presented the proposed budget for 2017-2018 which projects revenues of \$9200 and expenditures of \$10400 giving a deficit of \$1200. It was noted that since the executive had

approved the budget projected revenues from both voluntary contributions and ad revenues have increased so that the actual deficit is likely to be smaller than that projected at the time the budget was drawn up.
