# Minutes for the Annual General Meeting-Thursday June 17, 2021

### **Zoom Meeting**

1. Welcome and Call to Order: 10:01 am.

Keynote Speaker: Dr. Lisa Porth, Dean of the University's Lang School of Business and Economics. Dr. Porth introduced herself and outlined the Business School's structure and aspirations. In particular, she addressed the role of the school as they develop a five-year Strategic Plan, in a post-Covid world, and the future, worldwide, for agricultural business security.

President's Remarks (J. MacInnes)

This was an exceptional year with executive and member meetings all held by Zoom, and communication to members by website, email and with newsletters. Jan expressed her appreciation for the service of retiring directors, those continuing and those who have let their names stand. She also thanked the University and UGRA members for their continued support.

Governance Report, changes to bylaws (P. Krell)

The governance committee proposed a change to the constitution, to align the fiscal year with the dates for membership renewal and to facilitate financial reporting.

<u>Motion</u>: To change Article VII, Section 4 of the constitution from "The fiscal year shall be from April 1 to March 31 of the succeeding year" to "*The fiscal year will be the calendar year January 1 to December 31.*"

UGRA Scholarship (P. Krell)

Given the rise in educational costs, the executive agreed to increase the limitation on other individual scholarships held in conjunction with the \$1500 UGRA Scholarship from \$1500 to \$2500.

The opening balance for the fund as of May 1,2019 was \$57,994, the closing balance at April 30, 2020 was \$55,226. Contributions of \$4,073 were offset by a negative

investment return (-\$5,291) and disbursement of the Scholarship (\$1500). The report from AA&D for 2021/2022 year will not be available until Nov. 2021.

Treasurer's Report and Nomination of Auditor (C Ralston)

For 2020-21 total receipts were \$7,060, lower than budgeted (\$9,600) due primarily to reduced member contributions during the pandemic. Expenditures of \$6,528 were also lower than budgeted (\$9,020), savings realized because all meetings of directors and members were virtual. The year-end surplus was \$531.

Given the change in fiscal year, Cathy presented a 9-month budget to the end of 2021. Expected receipts are \$5,750, including member contributions, interest and advertising revenue. Projected expenditures are \$5,670, including costs for the newsletter, website, Zoom account, office supplies and an in-person Fall Forum. There was some discussion regarding the merits and costs of continuing to publish a hardcopy newsletter. This was referred to the directors for further discussion.

2020-21 financial statements were reviewed by L. Shuh, CGA, CPA (retired) who indicated that "The statements and the detailed reconciliations, bank statements and supporting documents are in agreement and support the final results as presented. Based on the statements as presented including the conference net results shared with UGRA, the Association is in a good financial position with total cash revenues of \$16,888 as of March 2021. This reserve would carry the equivalent of 2.5 years of the 2020/2021 expenses (\$6,528)." He also noted that revenue from member contributions has declined yearly since 2016-17.

Given that Larry Shuh will is standing for the UGRA Board of Directors, and if elected would not be eligible to act as reviewer, the treasurer proposed that the Board be given authority to appoint a reviewer for the coming year.

Motion: To permit the Board to appoint a reviewer of the financial records of the 2021 fiscal year.

Pension and Benefits Update (D. Badger)

Conversion of the Guelph pension plan to the UPP will take effect July 1, 2021. The final Guelph payment will be June 30, the first UPP payment is July 1, with payments thereafter falling on the 1<sup>st</sup> of every month. Updates: <a href="www.universitypension.ca">www.universitypension.ca</a> An interactive website <a href="www.myupp.ca">www.myupp.ca</a> will be available soon, with information sessions scheduled for the fall.

Member services for Guelph retirees will continue to be managed by Guelph's HR Dept for the foreseeable future. Indexation is based on the previous May-April CPI;

therefore, no adjustment is expected for this year. Maybe next year, if CPI continues to rise. Check Guelph's HR website.

The University's Pension Committee will be disbanded; thus, Doug will no longer represent UGRA. The members present and the executive expressed thanks for his 6 years of conscientious service.

United Way (Daniel Gillis, 2020 co-chair)

UGRA members were thanked for their sustained strong support of the United Way. Retirees had both the highest dollar amount and number of contributors in the University's United Way campaign.

Unfortunately, the new UPP does not permit payroll deduction of donations. The United Way committee is investigating ways to have recurring on-line donations credited to a donor group, such as UGRA.

UGRA Adventures (V. Tremblay)
